COMPLAINT BEFORE THE HONB'LE SESSIONS JUDGE AGAINST THE INVESTIGATING AGENCIES/INVESTIGATING OFFICER FOR NOT INVESTIGATING THE CASE IN ACCORDANCE WITH LAW.

MOST RESPECTFULLY SHOWETH: -

- That this instant complaint is being filed by Biswanath Borgohain, S/o-Bimal Borgohain, R/o- Chapakhowa, School Chariali, Sadiya, Dipjyoti Neog, S/o-Nabin Neog, R/o- Chapakhowa, Milan Nagar and Manuj Buragohain, S/o-Karnabir Buragohain, R/o- Chapakhowa, Nijarapar, the informants in the above mentioned FIR lodged at Dholla police station as Dholla PS Case no 22/2024.
- 2. That the complainants herein had lodged a First Information Report on 12th September, 2024, against the accused persons namely Mr Mrinal Deka, the then Superintendent of Police, Sadiya; Mr Bibhas Das, Additional Superintendent of Police, Tinsukia; Mr Si-im Sing Timung, Officer-in-charge, Sadiya Police Station; Mr Debashish Dekari, Officer-in-charge, Dholla Police

Station and 10-12 unknown police personnel for orchestrating extrajudicial/fake police encounter with the complainants injuring the complainants grievously.

- 3. That on 23rd December, 2023, Biswanath Borgohain, Dipjyoti Neog and Manuj Buragohain went for a picnic to a nearby picnic spot which is in Arunachal Pradesh in the Maruti 800 car owned by Biswanath Borgohain. They reached the picnic spot at around 2:30 pm and there they found other people who were also there for a picnic by the river side. Several of them were known to them as they were mostly bus conductors and drivers and were former colleagues of them i.e., Manuj Buragohain and Bishwanath Borgohain. They, along with the other people at the picnic spot, enjoyed the picnic.
- 4. At around 6 pm, they thought of returning home and started their journey by the Maruti 800 vehicle. As they were drunk, they were driving slowly and stopped by the road occasionally. At one point of time they felt drowsy and sleepy. The fuel of the car was also low; therefore, they stopped the car and slept inside it. As they were sleeping inside the car which was parked by roadside, Assam Rifles Personnel came and picked them at around 10 pm and took them to their camp and the Assam Rifles Personnel interrogated them whether they are linked to any banned organization or going to join banned United Liberation Front of Assam a militant organization, to which they denied. The Assam Rifles Personnel showed them some photos in their mobile phones asking them whether they knew any of them or not, to which they denied.
- 5. The Assam Police led by Superintendent of Police Mr Mrinal Deka arrived at around 12 am in the Assam Rifles Camp. They could recognize Mr Mrinal Deka as they have seen him on TV and in the newspaper several times earlier. Mr Mrinal Deka, S.P., Mr Bibhas Das, ASP, Si-im Sing Timung, Officer-in-Charge, Sadiya P.S. and other police personnel who arrived at Assam Rifles-Camp started drinking alcohol with the Assam Rifles officers and after sometime the complainants were made to seat in Assam Police vehicles and were being

Sou: Drp JATI Neag Sai: Biswandh Bourgahain STI'MONY BRANGHAIN taken via a road inside Hahkhati Forest Reserve instead of Highway. Dipjyoti and Manuj were seated in the same vehicle while Biswanath was seated in a different vehicle. A total 6 Assam Police vehicles were there and around 10-12 police personnel accompanied the police party.

- 6. The complainants/informants were brought via highway and the convoy waited at the Dirak gate for several minutes. However, after crossing the Dirak gate and going several kilometers through the highway towards Kakopathar took a U turn and went back and stopped at the point which connects the Hahkhati reserve forest road. After several minutes of waiting at the point, proceeded towards the encounter site at the Hahkhati forest reserve.
- 7. That the police convoy reached the Hahkhati Forest Reserve at around 3 am on 24th December, 2023, the vehicles were stopped and the three complainants were taken down from the vehicles and were forcefully made to lay down by their face towards the ground and the Superintendent of Police Mr Mrinal Deka started shooting them one by one from closed range. Mr Mrinal Deka with his own hand shot two bullets at each one of them from close range on their leg. Dipjyoti was shot first, Manuj second and Bishwanath third.
- 8. The police party led by Mrinal Deka staged a fake encounter and tried to kill all of them and also wanted to implicate false charges on them by lodging an FIR against them stating that they tried to snatch a pistol from a police officer and wanted to flee and in self-defense they were shot upon.
- 9. That it is not true that Dipjyoti Neog tried to snatch the pistol from the officer-in-charge of Dholla PS from his holster and wanted to run away. It is not true that any of them wanted to flee. It was also practically not possible to flee from police personnel who were around 15 nos and heavily armed.

- 10. That Mr Mridupaban Das, SI (P) was appointed as the case investigating officer on 12/09/2024 by Mr Debasis Dekari, officer-in-charge of the Dholla Police station who himself was one of the accused in the above-mentioned FIR. After a few days' police personnel visited the informant's home and took a statement which was video recorded.
- 11. Subsequently the case was transferred to Criminal Investigation Department (CID), Ulubari, Guwahati, vide ECF No. 340515/1002 dated 19.10.2024 and the investigation was entrusted to Mr Nayanmani Das, Inspector (UB), CID. who didn't start the investigation.
- 12. However, the statements of the informants were recorded by newly appointed investigating officer Mr Nirmal Ch. Biswas, APS, Dy. S.P, CID (HQ) at Guwahati on 06/12/2024.
- 13. That the current investigating officer in the case is Dy. S.P of CID and is junior in rank to the accused persons; Mrinal Deka, the then SP, Sadiya police district and Bibhas Das, Additional SP, Tinsukia, which is a clear violation of the PUCL guidelines issued by the Supreme Court of India.
- 14. Further, in clear violation of guidelines in **People's Union for Civil Liberties** & Anr V. State of Maharashtra & Ors. (2014) 10 SCC 635, namely:
 - "31.3. An independent investigation into the incident/encounter shall be conducted by the CID or police team of another police station under the supervision of a senior officer (at least a level above the head of the police party engaged in the encounter). The team conducting inquiry/investigation shall, at a minimum..."
- 15. That the Commandant of the 2nd Assam Police Battalion, Makum, Tinsukia has also recorded the statements of the victims without letting the informants know as to how he is empowered to investigate the case when the case has been transferred to CID and a different investigating officer was already being

appointed and has taken statements of the informants. The informants through letters addressed to the commandant sought information regarding the same but have not received anything else so far. However, the Commandant on 19th December, 2024, visited the informant's home and took statements which were illegal.

True copy of the summon of the Commandant and subsequent letter sent by the complainants/informants addressed to the Commandant, 2nd APBn dated 26/10/2024 are annexed as **Annexure A1 (Colly).**

- 16. That for more than three months, police have been investigating the matter, till date no statement of crucial witnesses has been recorded by the case investigation officer. Statement of Mr Gojen Borgohain and Mr Nipon Buragohain, the informants in the Sadiya Police case no 198/2023 has not been recorded.
- 17. That the entire case arises from FIR No 198/2023 of Sadiya Police station which was allegedly lodged by Mr Gojen Borgohain and Mr Nipon Buragohain under duress and subsequent FIR 49/2023 of Dholla Police Station which was lodged against the victims after the fake encounter took place.
- 18. That in a span of 3 months three (03) investigating officers were appointed which casts doubt on the intention of the investigating agencies in conducting a fair investigation.
- 19. Further the complainants/informants in their FIR had specifically mentioned the provisions of law which the case attracts, but the officer-in-charge of Dholla PS while registering the FIR had diluted the case by not inserting the relevant provisions of law which are sections 34, 307, 120, 120B, 166A, 201, 202, 203, 211, 212, 217, 218 & 350 IPC.

20. That this Hon'ble Court is having jurisdiction to hear this complaint in terms of People's Union for Civil Liberties & Anr. v. State of Maharashtra & Ors., (2014) 10 SCC 635, Judgement which reads as under:

'31.16. If the family of the victim finds that due procedure has not been followed or there exists a pattern of abuse or lack of independent investigation or impartiality by any of the functionaries, it may make a complaint to the Sessions Judge having territorial jurisdiction over the place of incident. Upon such a complaint being made, the concerned Sessions Judge shall look into the merits of the complaint and address the grievances raised therein."

- 21. That police encounters/extrajudicial killings are a serious crime-murder/culpable homicide and is an offence against the entire society, and raises question the existence of the Rule of law. That the offence amounts to punishable under IPC, disciplinary action must be initiated against the police officers found guilty of wrongful encounter without delay and for the time being that officer must be arrested.
- 22. If the accused persons were not arrested immediately, they would definitely try to destroy the facts of the case which is definitely against the law and injustice to the victim. The investigating officer is not giving satisfactory answers about the investigation and has not made any arrest.
- 23. That the right to fair, effective and speedy investigation is the backbone of rule of law quaranteed under Article 21.
- 24. That direction to be given to the concerned authorities to take necessary action for speedy justice. Access to speedy justice is a fundamental right of every citizen. Delays in justice can lead to denial of justice.
