Hope this email finds you in good health and spirits.

1. You may be aware that the Hon'ble Tripura High Court by its Order dated 07.11.2022 in Writ Petition (C) (PIL) No. 17 of 2022 has constituted this High Powered Committee for discharging various functions including issuing of recommendation for transfer of Elephants. The scope and jurisdiction of this High Powered Committee was extended to the whole of India by an Order dated 03<sup>rd</sup> March 2023 passed by the Hon'ble Supreme Court in Special Leave Petition (civil) No.12246 of 2022.

2. In discharge of the functions and duties of the High Powered Committee a permission dated 10 January 2025 has been granted to Vantara "Radhe Krishna Temple Elephant Welfare Trust" (said Trust) for transferring 21 Elephants from District: Namsai, Arunachal Pradesh to the Elephant camp at Moti Khavdi, District: Jamnagar, Gujarat.
3. The convoy of the said Trust will start the journey with the 21 Elephants from Arunachal Pradesh between 18<sup>th</sup> January to 20<sup>th</sup> January 2025 and completes the same within 7-8 days and the convoy will pass through your esteem States. The Trust has expressed an apprehension with the High Powered Committee that there may be untoward stopping of the convoy or untoward incidents in the process of transfer.
4. At this juncture your attention is invited to Paragraph 37(m) of the Order dated 07.11.2022 passed by the Hon'ble Tripura High Court as confirmed by the Hon'ble Supreme Court wherein, it is directed as under:-

*m. In cases where the Chairperson of the Committee recommends that an Elephant or Elephants be transferred to the camp of the respondent No.3, the concerned Chief Wildlife Warden shall ensure that the transfer of the Elephant is undertaken in the most appropriate manner conducive to the Elephants and further the concerned Chief Wild life Warden shall request the jurisdictional police to ensure smooth passage of the Elephant concerned.*

**Such jurisdictional police shall be bound to render all assistance to ensure smooth passage of the Elephant concerned.**

5. Therefore, in terms of the Order of the Courts as well, your good offices are required to render all assistance to ensure smooth passage of the Elephants through your respective states.
6. In view of the above, for and on behalf of the High Powered Committee, you are requested to please ensure that there is no untoward incident or law and order issue. You are requested to direct your concerned officers to provide escort or security if

required and / or render all assistance to ensure smooth passage of the Elephants through your respective States.

7. A copy of this communication is also sent to all other members of the High Powered Committee and the Trust officials for taking all steps as required for enabling compliance as deemed necessary.
